By signing, you are agreeing to the waiver on this agreement on behalf of yourself and the household members you are registering.

(ALTHOUGH THIS WAIVER IS REQUIRED TO ATTEND YOU MAY BE WAIVING CERTAIN LEGAL RIGHTS YOU AND/OR YOUR HOUSEHOLD MEMBERS THAT YOU ARE REGISTERING FOR, MAY HAVE).

FOR THE PURPOSE OF THIS AGREEMENT: The term HOUSEHOLD includes those living in your home that you are registering as listed below on this form. **Please have each adult, 18 and over fill out their own waiver.** Minors only need to be listed on one parent/guardian form.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I (and my household) may be exposed to or infected by COVID-19 by attending HANOVER MISSIONARY CHURCH, and that such exposure or infection may result in personal illness, injury, permanent disability, or death.

I understand that if I am 60 years of age or older, or if I am immunocompromised due to medication or an existing health condition or disease, I may be more susceptible to death or serious illness from COVID-19 and am taking increased measures to avoid infection, including wearing a face mask, social distancing or participating in online services.

I understand that the risk of becoming exposed to or infected by COVID-19 at HANOVER MISSIONARY CHURCH may result from the actions, omissions, or negligence of myself and others, including, but not limited to, HANOVER MISSIONARY CHURCH employees, volunteers, attendees, program participants and their families.

I agree while on premises or while participating in off-premises activities events of HANOVER MISSIONARY CHURCH to abide by all rules and recommendations posted in signs on the premises and otherwise communicated in writing or verbally by HANOVER MISSIONARY CHURCH, its directors, officers, employees and volunteers, to protect my health and safety, including minors in my care.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any illness or injury to myself (or to my household), including, but not limited to, personal injury, disability, death, damage, loss, claim, liability, or expense, of any kind, that I (or my household) may experience or incur in connection with my (or my children's) attendance at HANOVER MISSIONARY CHURCH or participation in its events, programs or activities.

On my behalf (and on behalf of my household), I hereby release, covenant not to sue, discharge, and hold harmless HANOVER MISSIONARY CHURCH, its officers and directors, members, employees, volunteers, agents and representatives, of all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any all liabilities, claims, actions, damages, costs or expenses of any kind based on the actions, omissions, or negligence of HANOVER MISSIONARY CHURCH, its directors or officers, employees, volunteers, agents and representatives, whether a COVID-19 infection occurs before, during, or after participation in any HANOVER MISSIONARY CHURCH program or activity.
